- **Included with the order form is the “Application to Stock Waters in the State of Maine” permit application**, please complete and mail to Dept of Inland Fisheries & Wildlife. **If you are submitting an application, please allow two+ weeks for IF&W to process your application.**

### **CONDITIONS OF PERMIT TO STOCK WATERS IN THE STATE OF MAINE**

All live freshwater fish taken from hatcheries, aquaculture operations or private ponds within the state and all live freshwater fish imported from outside the state shall, while being transported, held in storage or offered for sale, be identified with the name and address of the original source in the following manner:

- Each fish or the container holding fish shall be identified by a tag, seal or sign that identifies the source.
- All fish shall bear identification as described above from the time they leave the original source until they reach their ultimate destination.
- All fish while in transit, must be accompanied by an invoice or other documentation describing the species involved, the number of fish involved and the destination of the fish.
- All live freshwater fish which are to be introduced into either public or private waters of the State shall, while in transit, be accompanied by the appropriate written Permit from the Commissioner as described in Title 12 M.R.S. 12510.

---

**A person may not introduce, import or transport any live fish or gametes into the State or receive or have in that person's possession fish or gametes without a valid permit; if convicted of this violation up to a \$10,000 fine may be imposed as described within Title 12 M.R.S. § 12509.**
